#### **Welcome and Introductions** (Westfall)

**Approval of the January meeting minutes** (Brockman) Westfall asked members if there were any additional changes to the February General Meeting Minutes. Harriet Little then made a motion for the minutes to be accepted, and it was seconded by Anne Gleason. The minutes were accepted for filing.

# President's Report: (Becky Westfall)

Thank you to the 11 members who took time to attend the Friends training session led by a representative from the SC State Library. We will continue learning about the important role Friends groups can play be attending the Friends of the SC Libraries Conference on April 3 at the St. Helena Branch of Beaufort County Library. If anyone would like to attend, please complete one of the registration forms tonight. These completed forms will be mailed tomorrow so we can beat the March 14<sup>th</sup> deadline for early registration. FOSL will pay the \$15 registration fee for the conference which includes lunch.

#### **Vice President's Report on Membership**: (Westfall for Williams)

In February, I received notice of 2 new members from the book sale and 5 renewals. From the library box, I received 2 additional renewals which brings our total membership to 238. Anne Gleason noted she had picked up three more new memberships at the PO Box on the date of our general meeting.

This month, the new member letter was modified; the FOSL bulletin board in the library was also updated with the new FOSL membership brochure. Williams has the inventory of remaining brochures from the 1,000 quantity that was ordered. Harriet Little suggested on the next printing, a year be added on the brochure.

#### **Treasurer's Report** (Gleason)

The 2020 Budget received final approval by vote of the membership. Harriet Little made a motion to accept the budget and it was seconded by Kevin Carroll. The Monthly Budget Report was provided to all members as well. Gleason reviewed again with the members how to choose FOSL as their Charity of Choice when buying through Amazon using the Amazon Smile option.

#### **Book Sale Committee Report** (Coffey)

Coffey advised the next book sale would be May 1st-May 3<sup>rd</sup> with the set-up being held on April 30, 2020. Coffey also reported purchasing an additional 500 bags as our inventory was low. #### **Programming:**

I will have a sign-up sheet for Harry Potter volunteers at the May and June meetings and will notify everyone ahead of time about which area they will be volunteering in so that there aren't any surprises on that day.

Our Teen Librarian, Elizabeth Neal offered to share \$200 of her FOSL Summer Reading funds to purchase copies of "Harry Potter and the Sorcerer's Stone" as giveaway books leading up to the July program. With the \$200 and a well-timed coupon purchase, we were able to buy 24 paperback copies. Discussion was held and it was determined FOSL will spend the money for bookplates for those copies.

I will share dates of other upcoming summer programs as we get closer.

Leslie discussed that the Library was to have a booth on SAT and SUN only at the Flowertown Festival and had a part-time employee that was to work on those days as well.
